

HEE HNY Workforce Transformation Budget (WTB) 2022/23

Core Confirmed Modules for Funding

Please note that:

- the below modules constitute the **core confirmed modules for WTB funding for Humber and North Yorkshire organisations**.
- for 2022/23, our in-area HEIs can also accept applications for other suitable modules against their funding envelope however the core modules must be prioritised in the first instance. Masters, research, and leadership modules will **not** be considered as suitable modules but CICs and non-NHS organisations can use the budget for CPD-type courses.
- we expect that in this case, it will be the organisation's responsibility to liaise with the in-area HEI regarding opportunities for other funded modules.
- HEE will be working closely with our HEIs to monitor activity on other funded modules outside of the core list.
- only those modules listed for out-of-area HEIs can be accessed against the WTB funding.
- where modules are **20 credits or less**, we would encourage our applicable organisations to use their CPD allocation to allow us to maximise opportunities for our CICs and non-NHS organisations who are not in receipt of CPD funding
- this **does not** affect the non-medical prescribing fund of which this will be used to support V300 applicants only.
